* Legal Guidelines On Grandparent Documentation:

Parent executes a Power of Attorney to authorize the grandparent full care, custody and control of a grandchild under the age of eighteen which allows the child to attend the district where the grandparent resides tuition free (RC 3309.52).

Grandparent executes a Caretaker Authorization Affidavit due to an inability to locate the child's parents or the existence of a custody order that prevents contact between the child and the parent, authorizing the grandparent full care, custody and control of a grandchild under the age of eighteen which allows the child to attend the district where the grandparent resides tuition free (RC 3309.65).

Both documents must be notarized and filed with the juvenile court within 5 days of their execution. RC 3313.672 states a copy of one of these forms must be produced in order for the child to be enrolled under it into a school district. **Please note the form is only good for one year**.
